4. REGISTRATION AND ACCREDITATION

Hebron Theological College (HTC) is a formally registered Nonprofit institution specifically established to train Christian leaders through SAQA accredited qualifications.

The HTC team consists of well-qualified staff with many years of experience in the Christian ministry and formal education.

HTC is delivers is services via a Memorandum of Agreement (MoA) with Excel Theological Training Academy (ETTA), a duly registered Skills Development Provider with the Quality Council for Trades and Occupations (QCTO) (Reg. nr. QCTOSDP01201127-2262).

By virtue of the operation of the MoA HTC is approved to facilitate training accredited by Quality Council for Trades and Occupation (in accordance with the Skills Development Act, 1998, (Act No 97 of 1998).

HTC is a member of the Association of Christian Religious Practitioners (ACRP) (Registration number: 19-05). The ACRP is a Professional Body registered by the South African Qualifications Authority (SAQA) in terms of the National Qualification Framework Act 67 of 2008.

5. SAQA REGISTERED QUALIFICATIONS

We offer qualifications registered with SAQA.

6. PURPOSE AND RATIONALE OF THE QUALIFICATIONS

6.1. General Purpose

The purpose of both these qualifications is to prepare Students to operate as Christian Religious Practitioners.

A Christian Religious Practitioner functions as the Pastor or ministry Leader who directs and conducts ministry functions, facilitates spiritual formation, nurtures fellowship and mutual care within the faith community, helps members to develop a Christian lifestyle, and provides strategic leadership that promotes obedience to the vocation and sustainability of the faith community.

A graduate will be able to develop a missional ability to share the good news of Jesus Christ and contribute to the holistic well-being of the community.

These qualifications are designed to prepare students for further formal academic studies at registered institutions.

6.2. Rationale

Generally, Christian churches in Southern Africa come from two distinct backgrounds. It is considered that one group, estimated to number approximately 9,000 qualified clergies, is more formal and historic in character. The other group is seen to be less formal and includes the Pentecostal, Charismatic, and African Independent Churches. Estimates indicate that there are approximately 186,000 pastors in this group.

Society and the Church will benefit from competent leaders.

7. CHRISTIAN RELIGIOUS PRACTITIONER NQF LEVEL 2

This qualification is an Occupational Certificate in the of field of Social and Human Studies (Field 07) under the Subfield Religious and Ethical Foundations of Society.

This qualification has replaced the previous National Certificate: Theology and Ministry and carries **156 Credits**.

This qualification is designed for religious ministers with little to no schooling or literacy and who did not have proper training opportunity in the past.

The benefit for society lies in the fact that these ministers will now have a common set of competencies notwithstanding their lack of education.

While Recognition for Prior Learning can be applied for, there are **no educational entry requirements** for this qualification.

It is important to note that some prospective students who do not have a Level 4 (matric or equivalent) qualification may wish to complete a NQF Level 4 bridging course which will grant them access to the NQF Level 5 studies.

7.1. Specific purpose

A qualified student will be able to:1

- Share the gospel in a specific context and to a specific audience.
- Build caring relationships in the faith community and respond to the spiritual and physical needs of members.
- Provide spiritual leadership and develop leaders in a faith community.

8. CHRISTIAN RELIGIOUS PROFESSIONAL NQF LEVEL 5

This qualification is an Occupational Certificate in the of field of Social and Human Studies (Field 07) under the Subfield Religious and Ethical Foundations of Society.

This qualification does not replace any other qualification and is not replaced by any other qualification and carries **237 Credits**.

The NQF Level 5 qualification is on a more complex level than the NQF Level 2 qualification and is required for religious ministers who wish to join the Ministry Fraternity. As a qualification, it will not only address training needs, but also provides access to higher qualifications.

This occupational qualification grants access to formal training for the vast majority of pastors in the less formal group who, because of geographical and financial reasons, or the lack of appropriate prior learning were historically excluded from access to formal training.

Hebron embraces the concept of a more practical approach to Theological training offered under the NQF Level 5 curriculum.

Society will benefit from quality training, linked to the development of professional standards and a system of professional oversight because it will go a long way to protect communities against irresponsible persons who misuse their position as spiritual leaders in the community.

While Recognition for Prior Learning can be applied for, **entry requirements** for this qualification is Level 4 (matric or equivalent) with English Communication.


As a Qualified Leader the graduate will be able to:²

9. ENROLMENT PROCEDURE

The enrolment process is the same for both NQF Level 2 and NQF Level 5 courses.

This process consists of two steps for which separate non-refundable payments are made:

- The first step is an Application Process to <u>REGISTER</u> as a student with HTC.
- The second step is an **Enrolment Process** during which **APPLICATION** for the desired studies is made.

During the second step of the process you will be required to upload different documents which will be used to determine

whether you comply with the minimum requirements for that course.

The following documents will be required to be uploaded during the Enrolment process:

- A <u>certified copy</u> of your ID Document or Passport (not older than 3 months).
- A certified copy of qualifications attained in the national education system and any other specified in Theology.
- Foreign Theological qualifications must be submitted to SAQA for evaluation at <u>www.saqa.org.za</u>

9.1. Application Process

If you desire to study for an Occupational Certificate at HTC, the following procedures is to be followed:

- To initiate the application process, go online to the "Course Book Store" tab in the top ribbon of HTC's website or follow this link:
 - https://www.hebroncollege.co.za/shop/
- Add the QCTO -Application fee (Non-Refundable) to the cart.
 Click "View Cart" and proceed to "Checkout".
- Complete "Billing Details".
- Tick "I HAVE READ AND AGREE TO THE WEBSITE TERMS AND CONDITIONS *
- Proceed to "Place the Order" to finish the Billing process.
- Complete the online Application form, download forms requiring your completion and upload the necessary documentation.
- Submit your application. You will see a successfully submitted notification on screen.

9.2. Enrolment Process

Immediately after Application Verification has been completed, you:

- Will receive an acceptance email confirming this and guiding the Enrolment process.
- Should follow the guidance to log into the Hebron Website to make the Enrolment fee payment,
- Must choose payment option for the course (i.e., Once-off, 12-, 18-, or 24-month payment option)
- Make the first payment of Course Fee in accordance with the chosen option.
- Must please take note the initial term payment includes a non-refundable Activation Fee,
- · Should anticipate an LMS reset pin e-mail,
- Once the Payment confirmation has been received, you will receive further instructions on how to proceed with the Study program.

10. RECOGNITION OF PRIOR LEARNING (RPL)

10.1. The Meaning of RPL

For purposes of Theological Studies under the QCTO, RPL has been interpreted as a process by which skills and knowledge can be assessed which a candidate has gained through informal or experiential learning. Once assessed, skills and knowledge are recognized, and credits can be awarded for such learning if they meet the respective requirements set for the NQF Level 2 and NQF Level 5 Certificates.

10.2. RPL Assessment

If you wish to have an RPL assessment to be conducted, please send an email to <u>info@hebroncollege.co.za</u>. We will advise on the steps to be followed.

Please ensure that you have the following documents at hand because it will be needed by the service provider to conduct the assessment:

- All theological training certified certificates.
- A certified letter from Church organization/s listing achievements and experience.
- Other certified evidence with which to ascertain relevant training and experience.
- Any video evidence.

10.3. Costs for RPL Assessment

The assessment of RPL applications is conducted by a external Service Provider and not by HTC. Fees payable in this regard will not be paid to HTC, but to the Service Provider directly.

10.4. RPL influence on the Course

Even though you will not be required to submit any assignments for those Modules you receive RPL for, it is highly recommended that you still attend classes because you will need to prepare for the FISA exams

Because of the integrated nature of the EISA exams, you will be required to work through the study materials of all the Modules in preparation of the exams, including those you receive RPL for.

Hosting of the LMS and the keeping of Statements of Records is a continuous function and must be kept current for comprehensive record keeping and auditing and inspection purposes by QCTO.

For the reasons set out in this section, it is unfortunate that no discount on course fees can be granted.

11. STUDENT SUPPORT

Support from Hebron Theological College (HTC) is provided by telephone, email, WhatsApp, video call/meeting, or during a personal visit by appointment to our facility at 7 Sports Road, Slaterville, Benoni, Gauteng, South Africa.

12. METHOD OF INSTRUCTION

The method of instruction for Knowledge Modules is via Teams/Zoom meetings once a week for 2-hour sessions in an online class context. Classes take place per the academic calendar which is published on HTC's website.

All sessions are recorded for purposes of auditing by QCTO and are also made available to students afterwards.

It is important to note that a 75% class attendance is required, failing by which a student can be barred from writing the EISA examination. Students are therefore encouraged to ensure in advance that they have adequate internet access.

13. ACCESS TO STUDY MATERIALS

A student profile is created on the LMS (Learner Management System) for all students who have successfully completed the enrolment process and have been accepted to study with HTC via the Distance Learning method of learning. Students will receive login details and the study material for a particular Module will be made available once the intake which they form part of have collectively reached that stage of their studies.

14. INDUCTION TO STUDIES

Once a student starts his/her studies with HTC, he/she will undergo the HTC Student online orientation to introduce Students to the three components (Knowledge Modules, Practical Modules, and Workplace Skills Modules) of the Occupational Qualification, as well as the online Learner Management System (LMS) orientation to ensure that he/she understands how the system works.

15. EISA FINAL EXAMINATIONS

Upon successful completion of the course a student enrolled in, he/she can take the EISA (External Integrated Summative Assessment) Examination. These exams can only be written throughout South Africa at QCTO approved examination centres.

Foreign students are required to travel to South Africa to write these exams. When the date and venue for the examination has been set, HTC will extend a written invitation to this extend for purposes of obtaining a visa.
